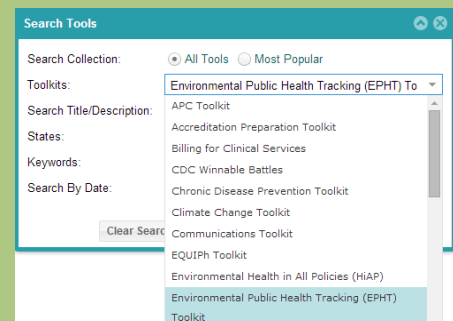

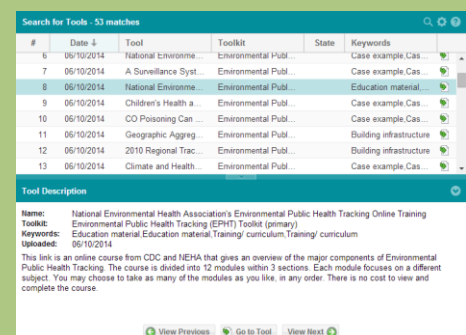
The National Environmental Public Health Tracking Program (Tracking Program) was created by Congress in 2002 and is

2. In the search tools popup box, select the EPHT Toolkit from the Toolkits dropdown menu.



3. Search keywords, titles and descriptions
4. Close search tools window or drag to the side
5. Select the tool from the list, and click on "go to tool"



administered by the Centers for Disease Control and Prevention (CDC). Its aim is to develop systems at the state and national levels to track many of the exposures and chronic health effects that may be related to environmental hazards. Before the advent of the Tracking Program, no systems existed at the national level to combine environmental exposure, hazard, and health information.

One goal of the Tracking Program is to protect communities by providing information to federal, state, and local agencies that will, in turn, use this information to plan, apply, and evaluate public health actions to prevent and control environmentally related diseases. CDC's Tracking Program established the National Environmental Public Health Tracking Network (Tracking Network) to obtain integrated health and environmental data and provide information to support actions that improve the health of communities.
